Changes for DP Operators

What changes have been announced by the Nautical Institute (NI)?

To ensure that DP Operators are keeping pace with developing standards in a fast-changing industry, they will be required to demonstrate Continuing Professional Development (CPD) alongside experience of at least 150 days of sea time.

When will the changes be implemented?

Now. If you are revalidating after January 2024, you will be required to have undertaken one year of CPD (two modules). This is why it is vital that you consider your CPD requirements as soon as possible.

If you are revalidating in subsequent years, you will still need to demonstrate CPD, but over a longer timeframe.

My certificate is due for renewal next year, what does this mean?

All DP Operators whose certificates are due to expire between 1 January 2024 and 31 December 2028, and have been unable to complete the new requirements for revalidating their certificate, will be issued with a 12-month indemnity letter once their online application has been submitted and paid.

The applicant must complete the new requirements of the CPD and/or courses and resubmit their application within a year of the issue date of the letter to be eligible to apply.

The indemnity letter is not to be used by the applicant to complete any of the sea time requirements for their application.



Year of cert. renewal	Requirements
2024	One year of an NI-approved CPD programme and online exam; OR five-day onshore NI DP refresher course and online exam.
2025	Two years of an NI-approved CPD programme and online exam; OR five-day onshore NI DP refresher course and online exam.
2026	Three years of an NI-approved CPD programme and online exam; OR five-day onshore NI DP refresher course and online exam.
2027	Four years of an NI-approved CPD programme and online exam; OR five-day onshore NI DP refresher course and online exam.
2028	Five years of an NI-approved CPD programme and online exam; OR five-day onshore NI DP refresher course and online exam.



Does the NI recommend any CPD providers?

IMCA's Key DP Personnel App which has been formally accredited by the NI for use in revalidating your DP Certificate. Other providers are also available.

Is CPD now compulsory to update my DP certificate?

Yes, CPD is now compulsory and is no longer voluntary if you wish to revalidate your DP certificate as an alternative to the five day DP refresher course.



What is the difference between doing the CPD and doing the five-day revalidation course?

The onshore five-day revalidation course takes place once every five years. It will incur travel and accommodation costs, time off for attendance, as well as one-off course fees.

The IMCA Key DP Personnel App is continuous over a five-year period and can be carried out in a DP Operators' spare time with no additional costs for travel, accommodation, or time off incurred.

How can I demonstrate CPD to meet the new requirements?

There are only two ways to demonstrate your CPD:

1. Attending a five day on-shore NI DP Refresher course and subsequently completing the online NI examination; OR
2. Be enrolled in an NI accredited CPD programme and completing the online NI exam.

Does this affect any other DP personnel?

Yes, the rule changes also apply to Vessel Maintainer personnel which will also require proof of CPD. As this is a relatively new scheme, it will not be required until 2026. However, as DP Operators are, you should start thinking about how you will demonstrate the new CPD requirements.

IMCA Key DP Personnel App

What is the IMCA Key DP Personnel App?

The IMCA Key DP Personnel App is a Continuing Professional Development (CPD) learning programme, in which the content has been developed by IMCA in collaboration with the NI. It provides CPD to DP Operators and other key DP personnel who perform a safety critical role onboard offshore DP vessels.

Designed to allow DP Operators to carry out CPD requirements at their convenience, the user-friendly App can be downloaded on any phone or tablet and links directly into the NI's Alexis platform offering immediate proof of CPD.



Why should I choose the IMCA Key DP Personnel App?

There are several reasons why you could choose the IMCA Key DP Personnel App to meet the new CPD requirements:

1. The first DP CPD App to be fully accredited by the NI.

What platform does it work on?

The App is available on both Android and Apple devices (iPhone, iPad) and is designed to work on both phones and tablets. It is also available to access online via an internet browser. You will receive instructions on how to download and access it once payment has been completed through the Nautical Institute's [Alexis platform](#).

How much does the IMCA Key DP Personnel App cost?

It costs £45 per module, or £90 a year.

Fees are charged at registration by the NI – and payment is made through the NI's Alexis Platform and excludes VAT (taxes).

IMCA has reduced prices by 10% in 2024.

The IMCA Key DP Personnel App is the easiest way to meet your new CPD requirements and is only available via the Nautical Institute's Alexis Platform.


I'm at sea with poor internet connection. Will the App still work?
