

7 Diving Equipment Issues

7.1 Update on diving equipment sub-committee issues:

Since its inception the Diving Equipment Sub-Committee has tackled various minor issues, serving as a central hub for review and feedback. So far, the committee have tracked twenty issues, resolving fifteen and leaving five still open. The recording system has proven effective. However, it was agreed that documents should be updated annually, with safety-critical issues addressed immediately and supported by an Information Note.

7.2 IMCA D051 Hyperbaric evacuation systems (HES) interface recommendations: Comms wiring for LSP different compared to NORSOK U-100. IMCA to approach NORSOK to align to D051 No change to IMCA document required. SB to approach NORSOK.

- 7.3 Discussion regarding IMCA D011 Guidance on Auditing Dive Systems, IMCA D015 Mobile/Portable/Daughtercraft surface supplied systems, IMCA D040 DESIGN for mobile/portable surface supplied systems:
 - D015 requires updating / expanded definition of Daughtercraft as these become bigger and more complex
 - D040 is required as a standalone and should not be merged with D023. Minor changes required to D040
 to reflect SCUBA replacement packages (SRPs). May also require minor revisions to D011 and D015

7.4 IMCA D018 Code of Practice for the Initial and Periodic Examination, Testing and Certification of Diving Plant and Equipment and the associated DESIGN documents outline major tests and regular examinations. However, duplicating these requirements across the DESIGN suite has created challenges in maintaining consistent testing standards. This redundancy has led to inconsistencies, especially in test periodicity, undermining our testing protocols' coherence and reliability. A streamlined documentation approach was proposed and unanimously agreed upon

7.6 JFD and lost bell survival suits: JFD reported that they have serviced several bell survival packs and have not encountered the same issue of a different suit size. This observation was supported by other members of the working group, who echoed that the issue discovered during the resuscitation in a bell project was most likely spurious. No further action is planned.

7.7 ROV: The ROV committee has reviewed and updated the R006 document. The Secretariat informed the DDMC that we have added a section for auditors to ensure protocols are in place to address the hazards and operational parameters of using divers and ROVs simultaneously.

7.8 UWSH / eCMID: A proposed section has been drafted for presentation to the CMID committee. This section will ensure marine auditors identify whether there is a policy for manned diving operations to support vessel inspection, maintenance, and repair, such as underwater hull husbandry. If approved, it will be placed above the Lock Out Tag Out section in the document.
