The actions from the previous DP Committee meetings were reviewed and discussed. The minutes from the previous meeting held in August were approved and will be signed off.

#### 2.1 Attendance review

The attendance tracking process was discussed and corrections noted. It was agreed to standardize the designation as "apologies" moving forward for simplicity.

#### 3 Work Program

#### 3.1 Documentation

- M103: Identified as top priority. A reminder will be sent to finalize updates.
- M252: Also prioritised; contains recent feedback to address.
- M217 (High Voltage): Requires further review.
- M250 (Batteries & Hybrid Systems): Requires major updates due to evolving technology. A work group will be proposed. Terms of reference will be drafted and submitted for CEO approval.
- Joint Emergency Preparedness Document: Will be cross-departmental. Focus on accurate DP section content.
- DP1 and M140 Documents: Feedback is limited; likely accepted. Consider enhancing M140 with data plots related to footprint.

#### 3.2 Handbook and Question Review

- The DP Practitioner Accreditation Handbook will be added to the review list.
- Several members emphasized the need for better guidance for seafarers transitioning to shore-based roles.
- It was agreed to review the accreditation exam questions for clarity, especially for non-native English speakers

#### 3.3 Practitioner Accreditation and CPD

- Accreditation Numbers:
  - Accredited Practitioners: 92 currently listed.
  - The committee discussed the need for a clearer onboarding path and better support for individuals transitioning into the practitioner role.
  - The possibility of listing accredited practitioners publicly on the IMCA website is being reviewed with consideration for data protection.

#### CPD Program:

- The DPO CPD app now has 8,675 registered users, with an average of 2,000 active users per month.
- Revalidation process updates:
- Year 1 candidates may complete Modules 1 & 2 consecutively.
- A mandatory 4-month gap must be observed before starting Year 2 modules

#### 3.4 Work with Other Organizations

- Joint Document on Single Fault Tolerance: In final review with Christopher Holland at OCIMF. Awaiting streamlining by a technical writer. Ongoing efforts noted with expected document publication shortly.
- See item 7.0 below for discussion following DP Asia with regards Data Centric Evidence.
- Overview of IMO ongoing.

Suggested updates to the DP Practitioners Accreditation handbook and exam questions added to 2025 objectives. Discussion included improving industry uptake and relevance of accreditation, especially in Norway and major operators.

#### 5 Mechanical/Electrical Failures

- Increase noted due to aging fleets, supply chain issues, and vessel reactivations.
- Noted problem with both hardware and skilled labour shortages impacting upon quality of deliverables.
- Contractual constraints undermining Planned Maintenance programs.

Discussions on how the DP Committee can tackle this issue, further thought is required. This will be a subject of a presentation at the 2025 IMCA DP Conference.

#### 7 Any other business

#### 7.1 Discussion on Data-Centric Evidence for DP Trials

- Key Issue: The committee discussed the need to define what constitutes acceptable data-centric evidence for DP trials.
- Current Challenge: There is confusion and inconsistency in understanding what qualifies as valid evidence, particularly in trial documentation and performance verification.
- Proposed Actions:
  - Define Clear Criteria: A formal definition of "data-centric evidence" should be developed to standardize expectations.
  - Provide Examples: It was agreed that concrete examples would be helpful to illustrate acceptable formats and types of data.
  - Avoid Ambiguity: Standardizing this aspect would help reduce misinterpretation and improve the consistency of DP trials across the industry.
