#### 3 Minutes of the previous meeting

#### **3.1** Approval of the minutes

# 4 Changes within ESC

*KT* introduced the new members of the ES Committee, including *HS* replacing Peter Burger for Fugro, *SH* replacing Shivani at McDermott, *CD* representing SBM Offshore. *CD* present in person introduced herself to the committee.

# 5 Updates from Work Groups/Dashboard

# 5.1 Circular Economy Workgroup

**KT** discussed the circular economy workgroup's plan to raise awareness and apply circular economy principles across member organizations through e-learning modules. He outlined the five modules focusing on introduction to ESRS and E5, disclosure requirements, risks and opportunities, metrics and targets, and practical application/case studies. *He* emphasized the importance of understanding and implementing these principles to achieve sustainability goals. *JB, NA, CD, LJ, JD* and *SR* discussed the challenges of applying circular economy principles to decommissioning projects. They highlighted the need for practical solutions and shared experiences to address these challenges effectively. The discussion also covered the importance of sustainable procurement, practical applications of circular economy principles within their businesses & the importance of understanding market timings (short, medium, and long-term goals).

# 5.2 Joined Circular Supply Chain event

The goal is to enhance collaboration and raise awareness about the importance of circular economy within the supply chain. *CC* presented the agenda for the combined event between the CE workgroup and the SS workgroup on 2<sup>nd</sup> of July in Amsterdam and explained the interactive session taking place in the afternoon. *MN* asked the committee for support in publicizing the event, requesting names of companies to invite and help in promoting the event through their networks. *LJ*, *JB* and *SC* proposed possible contacts to invite to the event such as BP, Norwegian Government, Shell etc. Details of events on the link IMCA Supply Chain and Circular Economy in Offshore Contracting.

# 6 ES membership survey

**MN** showed the results of the IMCA membership survey for the ES questions, highlighting the programs and initiatives members would like to see, including guidance documents, bulletins, audits, assessments, webinars, awards, and podcasts. **MN** noted that a large number of members were not aware of the self-assessment tool, suggesting the need for more communication and explanation about its purpose and use.

# 7 ES – Self Assessment tool

**MN** gave an update on the timeline for the self-assessment tool. At the moment the launch is facing delays due to IT transition to the new website being delayed.

# 8 Planning 2026

MN announced that IMCA's new COO Jamie Chestnutt will support membership, IT and budgeting activities. She explained that as part of the new budgeting process at IMCA the timeline to decide on activities for 2026 begins in June- September when IMCA board meets to finalise the budget . **NA** discussed the committee's objectives and priorities for 2025 and the importance of feedback for future planning, with **JV** suggesting the need for clear connections between actions and objectives, . The discussion included the need to ensure that all actions taken by the committee are clearly connected to its objectives. Members also stressed the importance of having a clear roadmap and understanding how each action contributes to the overall goals. **NA** encouraged open communication and regular feedback from all members.

*EC, JV* and other members discussed the importance of having clear terms of reference for the committee and workgroups, Current ToR exist for SS and CE working groups, these will be shared for all members to provide feedback.

# 9 Advocacy

**MN** mentioned the opportunity for advocacy and communication with regulators, including the IMO, through the MPRA committee.

- the upcoming global summit agenda & sponsorship on November 26<sup>th</sup>-27<sup>th</sup>
