

7 Diving Equipment Issues

7.1 Update on diving equipment sub-committee (DESC)

Dave Slater gave an update on the diving equipment sub-committee.

• Terms of reference for the committee was required and included as part of the pre read, this set out the roles, responsibilities and objectives of the committee. Requires updating to include a reference to the IMCA GDPR Policy.

• It was agreed that the committee recruit an additional four members to cover the necessary disciplines. The recruitment process will be overseen by the IMCA Diving Manager and the DDMC Chair and Vice Chair, with read-only access provided to the subcommittee.

DESC Action Tracker

 Mike Jessop and Dave Slater would continue to have editing rights to the DESC action tracker. The nominated support personnel will get read only access

Lifting and rigging additional updates

 Additional changes have been proposed to the lifting and rigging terminology and supporting sheets in D018. These changes involve updated terminology and were included in the pre-read materials.
 DDMC agreed to review the sheets and proposed changes and feedback by the end of July 2025.

Square Medical Locks

• The design of the door (opening inwards) constitutes an intrinsically safe design. Some auditors reject square medical locks due to the lack of an interlock arrangement. DDMC agreed that a footnote be added to DESIGN about this lock.

Composite Cylinders

• DDMC agreed to proposed changes to the composite cylinder's sheets in D018 during a previous committee meeting. It was agreed that a separate sheet be created and included within D018.

Role of an Auditor during a DESIGN audit

 Concerns were raised about clients' expectations of auditors, specifically the verification of Failure Modes, Effects, and Criticality Analysis (FMECA). There is a need for clear definitions of auditors' responsibilities to ensure industry consistency. DDMC agreed to this change.

Bell Diving Diver Gas Supply Issue with Terminology in Diving Equipment Systems Inspection Guidance Note (DESIGN)

• A member raised an issue about the primary and secondary supplies for the bell. DDMC agreed that the text requires a small update, but this needs more input.

Changes to DESIGN suite of documents

- The current DESC members have introduced working versions of the DESIGN suite that include tracked changes to clearly highlight proposed modifications.
- The intention is to grant the DDMC read-only access to these documents to review the proposed updates and provide comments where appropriate. David Slater will coordinate with IMCA's IT department to facilitate access to the relevant files.

• David Slater questioned whether both Excel and Word versions of the DESIGN suite are necessary. The DDMC agreed that the Word version is largely redundant and could be phased out. However, this should only occur following the publication of an Information Note (IN) to formally advise industry of the change.

7.2 IMCA D016 (Lift bags) challenges

• Simon Binsted gave a presentation on the challenges from clients on air lift bags. Quarantine of equipment is to be included in D016. It was also discussed that the guidance needs to be updated so that it is less open to interpretation and the '1.5 times the upthrust of the lift bag' statement needs to be qualified.

8 General Updates:

8.1 IDIF meeting, Jakarta, April 2025

Topics of discussion focussed mainly on regional in-water diver training and improving safety standards in the region. It was noted that with ADCI in the vice chair role, the IDIF's TOR were being adhered to.

8.2 DMAC update

DMAC discussed the following at April's meeting:

- Changes to the constitution and different ways of recruiting committee members to ensure the relevant experience and knowledge going forward.
- The possibility of utilising accelerated decompression in shallow saturation operations as an alternative to hyperbaric evacuation. Proposal to form a work group to undertake further investigation and modelling to better understand the risks/benefits.
- DMAC documents now have a new look and include a version history and document summary on the front page. DMAC 26 Saturation Diving Chamber Hygiene has been revised and published on the website in the new format.

The next meeting will be at the NUI event in Bergen where they will celebrate 50 years of DMAC. Work is ongoing to secure guest speakers for a seminar to commemorate the milestone.

9 Havtil presentation on IMCA recognition of Norwegian diving supervisors qualification

- Havtil presented on the topic of mutual recognition of air diving supervisor certification and the challenges in finding qualified supervisors.
- Discussion on the status of the Norwegian air diving supervisor training program and compared it with IMCA requirements.
- The gaps identified included differences in entry requirements, course duration, and panel time.
 Havtil also explored the potential for mutual recognition of Norwegian certification with IMCA to facilitate international mobility for certified supervisors.
- A decision was made to form a work group to investigate this further.

The committee agreed that the scheme is useful for gaining IMCA qualifications where it is otherwise impossible. It was agreed that the secretariat would continue to develop the scheme.
