4 Final Program for Ghana

The following were discussed

MN:

- Provided an overview of the diverse mix of companies and organizations attending the Ghana event, including energy companies, contractors, consultants, and non-profits.
- Outlined the finalised agenda for the Ghana regional event, including session topics, speakers, panel discussions, and post-event activities.
 - o Advising the group that Iain Grainger, the CEO, will not be in attendance; however, a recording had been arranged for his speaking slot should he not be able to do a live dial-in, which is the main plan.
 - She also highlighted that JS will be the only attending member of the EA committee

DB was also updated on the planned stakeholder engagement with the Ghanaian Petroleum Commission and **BC** will attend the meeting with the Nigerian Diving Association. **MN** shared the plans for an IMCA's half-day outreach at Ghana International School to promote offshore careers to students, and with support from **JS** and local professionals - Sarah Precious who is a young female Ghanian diver

5 Objectives and next regional planning

DB and **MN** reviewed the committee's progress on objectives set at the end of the previous year, including member engagement, safety focus, emerging talent initiatives, and strategic feedback to the IMCA board. All were in good progress. **DB** and **JS** discussed potential locations for future regional meetings, considering logistical challenges in Namibia and Angola, and the importance of member input in venue selection.

LB and, **EB**, discussed expectations for committee support at the KL Global Summit, including sponsorship, attendance, and award nominations, with **EB** and **ES** confirmed their participation.

LD highlighted that the committee consider to feedback to the IMCA board on matters of strategic interests and association, and the benefits to the region. E.g., the whistle-blowing on diverse safety as it's a hot topic. Also to encourage more member participation.
