5 Work Program

1. Underwater Radiated Noise (URN)

- The committee reviewed recent IMO guidelines and discussed the importance of assessing underwater noise. Members highlighted a lack of current measures by most organizations.
- Notable updates included the IMO's new guidelines on underwater noise, driven by Canadian advocacy.

2. STCW Update

- Discussion focused on revisions addressing emerging technologies, mental health, and bullying/harassment prevention (SASH). Topics including mental health, gender sensitisation, and bullying prevention were emphasized. Ongoing revisions to the STCW Convention were noted as critical.
- Noted US Coast Guard's push for mandatory DP certification under STCW Part A

3. Ballast Water Quality

- Updates on the Ballast Water Management Convention were discussed. Challenges with existing technologies and reporting were noted.
- Marine Committee's role emphasised in providing feedback on practical implementation issues.

4. NOx Tech Code

- Anticipated amendments were outlined, with a focus on aligning guidance with upcoming changes.

5. Low and Zero Carbon Fuels

- A discussion highlighted industry challenges in adopting low/zero carbon fuels due to supply chain issues.
- Action: Strengthen collaboration with fuel suppliers and document progress

- Margaret Fitzgerald provided insights on the revised U.S. Coast Guard requirements for video and audio surveillance (SASH initiative). The committee resolved to seek clarity on the implications for non-U.S. flag vessels operating in U.S. waters.
