Minutes of the previous meeting 3

3.1 Approval of the minutes

The minutes were agreed and were duly signed as an accurate record by the Chair.

3.2 Matters arising from the minutes not covered by the agenda

There were no matters arising from the minutes that were not covered by existing agenda items. All previous actions have now been met.

4 Election results

There were 23 nominations and 12 people were elected to the committee. **MN** welcomed and congratulated the new members.

5 Welcome and Apologies

MN, *GL* and *DB* welcomed the new committee members and introduced themselves. All the committee members in turn introduced themselves.

6 Objectives review and Leadership

MN outlined the Terms of Reference for Europe and Africa committee. These include working in compliance with the competition compliance policy, using skills and expertise from the committee to develop a workplan for EA, keep a braise with current developments in this region, keeping the profile of this committee raise and high working with regulators and local organisations.

DB mentioned that recently the team went to IMCA team building event to plant 1500 trees and learned how to set SMART objectives. He mentioned that one of the objectives of the committee could be to be working with EU regulators as that is something IMCA is taking forward in 2025 (advocacy). **CL** agreed and mentioned that objective number 6 is one of the most important such that IMCA is helping members in this region that are facing challenges.

DB mentioned that normally the committee is elected and then the Chair and Vice-Chair are selected by the committee but that in this case he suggested to keep Cintya as Chair and Rolf as vice chair up until after the first in person meeting and then decide after that. There were no objections. ES mentioned that in another group that he is part of they don't elect a Chair but only a Vice Chair that take over the chair place after a period of time. **MN** will take it into consideration.

7 Date and Potential Agenda of Next Regional

The committee discussed the location and timing of the next in person regional. Events like the Africa Energies Summit in London in May and OMC Med Energy in Ravenna were talked about as possible events to align the Europe regional with. The event in London is quite expensive so members might not attend it. For the African regional it might be aligned with the AOW Energy in Ghana in September. *RR* suggested putting together a list of events for 2025 on the Offshore industry that members would go to. *AL* suggested that there is Ocean Business in Southampton in April as well.

In terms of agenda *MN* outlined the previous regional meeting agenda from Aberdeen and asked the committee to think about possible speakers and topics. For the next regional in Africa, Ghana in September with a collab from someone local seems the option to choose. *RR* and *AL* mentioned that the price for AOW is very expensive so a lot of companies might not attend it. Some potential topics are: Net Zero shipping industry, Diving technologies, IMO emission reporting. *EB* suggested CSRD reporting and ETS is an important topic and that if we bring in an expert it could be very useful. *DB* also suggested ROV as a topic. *ES* suggested that John from the Nautical institute in London could be a good speaker to give an update on latest competence. *WD* also mentioned All energy event in Glasgow.
