## Grading of IMCA guidance documents

IMCA has established a hierarchy of compliance terms for its guidance documents, similar to the nomenclature used elsewhere in the wider offshore energy industry, using the following three descriptors:

- ◆ **IMCA code of practice (CoP)** – A document produced by the Association, the uniform application of which is recognised as essential for the safe and efficient conduct of marine contracting projects. IMCA expects the highest level of compliance with this category of document from its Members.
- ◆ **IMCA recommended practice (RP)** – A document produced by the Association, the uniform application of which is recognised as necessary for the safe and efficient conduct of marine contracting projects. IMCA expects a high level of compliance with this category of document from its Members.
- ◆ **IMCA informative guidance (IG)** – A document produced by the Association, the application of which is recognised as useful for the safe and efficient conduct of marine contracting projects. IMCA expects its Members to take appropriate account of this category of document when planning, managing and conducting their marine contracting projects.
